**Dear National Federation Presidents  
Chairmen of National Judges' Committees**

World Archery Americas will hold a **Continental Judges' Seminar in Halifax, Nova Scotia, Canada on May 30 to June 1, 2022** (Prior to the Youth and Masters Pan Am Championship). This seminar will be presented by former International Judges now Continental Judges Randall JONES and Robert PIAN (World Archery Target Committee Deputy Chair). All sessions will be conducted in English only.

Only judges who have been National Judges for at least two years and endorsed by their National Federation are eligible for Continental Judge Certification. (Per WA Rulebook 1, Appendix 4) Sit-ins are welcome. Registration forms must be emailed to [worldarcheryamericas@gmail.com](mailto:worldarcheryamericas@gmail.com) by March 15, 2022. (Form is attached).

Please review travel requirements to and from your country) and Canada. (See your consulate.) Please be aware of the Canada entrance requirements including Covid requirements.

**Lodging:** The seminar will be hosted at the Best Western Plus Chocolate Lake Hotel in Halifax. (250 Saint Margaret's Bay Road, Halifax NS B3N 1J4) Information on the hotel and room prices are attached. The hotel rate for up to two per room includes breakfast. Lunch and dinner are not included in the hotel room rate. Hotel reservation and payment is made via online system after registration form acceptance.

**Airport/Hotel Round Trip Ground Transportation:** Provided for an additional fee, see below. Halifax Stanfield Airport (YHZ) is the designated event airport. Note that ground transport time between the airport and hotel is estimated to be an hour. Ground transport reservation and payment is made via online system after registration form acceptance. Provide flight information.

**Meals** are not included in the seminar registration fee.

- Breakfast is provided at the host hotel, see hotel information.
- Lunch and Dinner: There is a restaurant at the hotel. Two to four restaurants are within walking distance of the hotel. Each participant is responsible for their own lunch and dinner meal expenses.

Note that the hands on session will take place in conjunction with the Youth and Masters Pan Am Championship. Please dress smartly for the hands on and testing day, however judge uniform is not required.

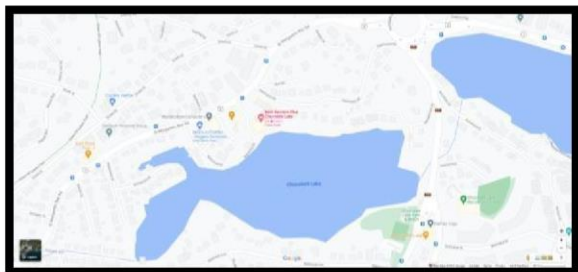
